CONSTITUTION FOR THE DIRECTION OF THE HISTORICAL FENCING CLUB

Article I: Name

This club is known as the "Historical Fencing Club."

Article II: Purpose

The mission of the Historical Fencing Club (HFC) is to enable students to safely and productively explore their interest in fencing as a Western Martial Art. This includes introduction to the theories and practices of fencing and to the philosophy from which it emerged.

Article III: Affiliations

For the purpose of quality instruction, the HFC is affiliated with a local fencing academy, the Academia della Spada.

Article IV: Membership and Dues

The membership of the HFC consists primarily of regularly enrolled students of the University of Washington.

Members must follow all rules of safety and conduct provided by the Constitution, Code of Conduct, and Instructor.

Members are required to pay dues in the amount of \$10 per meeting or \$30 for one month (four meetings). These payments do not carry over should a member miss a session. Dues adjustments may be negotiated with the Executive Council on a case-by-case basis¹. These funds will be spent exclusively in the hiring of the Instructor, the acquisition of club equipment, and the furtherance of club goals, as approved by a 4/7 majority of the Executive Council. Dues may be adjusted by a 4/7 majority of the Executive Council.

Only Members in Good Standing² will be eligible to sit on the Executive Council, either as Officers or as Members at Large³.

¹ Should a member be unable to pay his or her membership dues, he or she may volunteer for the club as deemed appropriate by the Treasurer. Other issues with the payment of dues may be resolved with the Executive Council on a case-by-case basis. ² A Member in Good Standing is a club member who regularly attends club meetings, who regularly pays his or her dues on

Article V: The Executive Council

The Executive Council consists of five Officers and two Members at Large who are responsible for the management of the HFC.

The Officers and their responsibilities are as follows:

President The President is responsible for promoting the club, managing meetings,

coordinating Officer activities, and delegating tasks.

Vice President The Vice President is responsible for assisting the President, as required.

Treasurer The Treasurer is responsible for the collection of dues and for taking roll. In

addition, the Treasurer is the liaison for on-campus fundraising.

Secretary The Secretary is responsible for the maintenance of club and member records,

including ensuring that all members have signed waivers.

General The General Administrator is responsible for room reservations and for website

Administrator maintenance.

In addition to the above duties, at least two Officers in addition to the Treasurer are to have access to the HFC's bank account. The Executive Council is responsible for additional duties not defined herein, but necessary for the successful administration of the club.

The Executive Council will meet no less than once per month to discuss relevant issues, distribute or redistribute duties and tasks, and to ensure the continuation of the HFC. The Executive Council will also delegate the responsibility of collecting, storing, maintaining, and transporting club equipment to its members.

Article VI: Elections

Officer elections will take place in the Spring of each Academic Year⁴. Eligible Officer candidates are University of Washington students who are also Members in Good Standing. Candidates will be determined through nomination by a current HFC member. This includes self-nomination. Voting will be done by secret ballot at a regularly scheduled club meeting. The meeting at which elections take place will be announced no later than a week in advance at a regularly scheduled meeting, with an email reminder sent no later than three days before the designated election meeting. Write-in nominations are acceptable. All nominations must be accepted by the nominee.

³ A Member at Large is a Member in Good Standing who shares in the additional duties of club government. He or she sits on the Executive Council, attends all executive meetings, and has the power to vote on all Executive decisions.

⁴ An Academic Year consists of Autumn, Winter, and Spring Quarters, as defined by the University of Washington.

The elected candidate for the position of Treasurer must be approved by a 4/7 majority of the incumbent Executive council. This measure is in place because Treasurer holds a position of special trust.

The Presidential candidates must have been Members in Good Standing for at least one Academic Year prior to their nomination.

Article VII: Amendments

All amendments to this Constitution must be approved by a 4/7 majority of the Executive Council.
