National Residence Hall Honorary Constitution

Article I - Name

The name of this organization shall be the National Residence Hall Honorary of the National Association of College and University Residence Halls, Incorporated, which shall be hereinafter be referred to as the NRHH.

Article II - Purpose

The purpose of this organization shall be to provide recognition for individuals who have been of outstanding service and who have provided important leadership in the advancement of the residence hall system at their respective schools. It shall also be the purpose of this organization to initiate and advance local chapters of the NRHH.

Article III - NRHH Board

Section I:

The officers of the NRHH shall consist of the Director and the National Associate Director(s).

Section II:

The NRHH Board shall consist of the Director, the National Associate Director(s), and the Regional Associate Directors.

Section III:

The qualifications and duties of the NRHH Board shall be prescribed in the By-Laws.

Article IV - NRHH Conference

The NRHH conference shall be held in conjunction with the NACURH Conference and shall be arranged by the NACURH Conference Chairperson and his/her staff with the advice and consent of the NRHH Director.

Article V - NRHH Headquarters

Section I:

The business headquarters shall be located at the school of the NRHH Director and the National Associate Director(s).

Section II:

The permanent headquarters of the NRHH shall be that of NACURH, Inc.

Article VI - Advisors

The advisor to the NRHH shall be the same advisor as the NACURH, Inc. advisor. There shall be an oncampus advisor located at the business headquarters of the NRHH.

Article VII - Chapters

Section I:

- A. Charters may only be issued to schools who are members in good standing with NACURH, Inc. as defined in the constitution of NACURH, Inc.
- B. Charters shall be issued by the NRHH Director in accordance with the Chartering procedure described in the By-Laws.
- C. A Chapter's charter will be considered lapsed at the termination of the school's membership with NACURH, Inc. or at the end of two successive NRHH conferences in which the chapter did not have voting rights. If the charter of a chapter has lapsed, that chapter must apply for a new charter before it may initiate more new members.

Section II:

- A. Each chapter shall have a constitution which must contain articles relating to name, purpose, membership qualification, selection procedures, officers, meetings, finances, and amendment procedures.
- B. All chapter constitutions shall be subject to the provisions of the NRHH; its By-Laws and amendments; and amendments to the NACURH, Inc. Constitution and By-Laws.

Section III:

National Residence Hall Honorary Constitution

Membership of individuals within chartered chapters will be prescribed in the By-Laws.

Article VIII - Amendments

Section I:

Amendments to this constitution may be proposed by the NRHH Board or by any chapters in good standing, at the business meeting of the NRHH Conference.

Section II:

Amendments must be ratified by 2/3 majority of chapters, in good standing, attending the NRHH Conference.

Article IX - Ratification

This constitution shall go into effect immediately upon 2/3 affirmative vote to the NACURH, Inc. membership attending the National Conference and shall void all previous constitutions and By-Laws.
