

**UNITE FOR SIGHT, INC.**  
**VOLUNTEER CODE OF CONDUCT**

As a Unite for Sight volunteer, I am a representative of the organization and I agree to fulfill certain standards of conduct, as follows:

1. I must complete Unite For Sight's Online Eye Health Course ([www.uniteforsight.org/course](http://www.uniteforsight.org/course)) prior to participation in Chapter programs;
2. I must comply with and observe all laws, ordinances, rules and regulations of the United States and the state or, in the case of non U.S. chapters, the country in which my chapter of Unite for Sight operates and all national, regional and local regulatory bodies having jurisdiction over the chapter.
3. I am prohibited from activities that could constitute the unauthorized practice of medicine, including diagnosing any eye condition or other disease, or providing any eye test beyond a visual acuity screening with a Snellen chart.
4. I must comply at all times with instructions from Unite For Sight, both with respect to activities involving eye care and matters of appropriate behavior and personal safety.
5. At no time may I:
  - a) Authorize the use of, or use for the benefit or advantage of any person, the name, emblem, endorsement, services, or property of Unite for Sight, except in conformance with Unite for Sight policy.
  - b) Accept or seek, on behalf of myself or any other person, any financial advantage or gain.
  - c) Publicly utilize any Unite for Sight affiliation in connection with the promotion of partisan politics, religious matters, or positions on any issue not in conformity with the official position of Unite for Sight.
  - d) Disclose any confidential Unite for Sight information that is available solely as a result of my affiliation with Unite for Sight to any person not authorized to receive such information, or use to the disadvantage of Unite for Sight any such confidential information, without the express written authorization of Unite for Sight.
  - e) Knowingly taking any action or make any statement intended to influence the conduct of Unite for Sight in such a way as to confer any financial benefit on any person, corporation, or entity in which I have a significant interest or affiliation.
  - f) Operate in any matter that is contrary to the best interests of Unite for Sight.
  - g) Engage in any Unite for Sight-prohibited activities which include:
    - 1) Attempting to influence legislation;
    - 2) Organizing or engaging in protests, petitions, boycotts, or strikes;
    - 3) Engaging in religious instruction; conducting worship services; providing instruction as part of a Unite for Sight-sponsored Program that includes mandatory religious instruction or worship; or constructing or operating facilities devoted to religious instruction or worship;
    - 4) Other activities as Unite for Sight determines will be prohibited, upon notice to my Chapter.

I understand that my participation in Unite For Sight-sponsored activities is subject to immediate termination if I violate this Code of Conduct.
